

The year 2020 has been a challenging year and the uncertainties in the economy outlook have caused many households struggling to put food on their table.

In spite of the four phases of MCO, Linaco was able to reach out to more communities and families through partners such as Food Aid Foundation, Kechara Soup Kitchen, Suriana Welfare Society, HELP Community Learning etc. Our team provided hope to the marginalized communities through food aid programmes.









WayBox is the brainchild of The Bountiful Eye Foundation (TBEF) with the intention of delivering food aid to targeted families while supporting local small and medium enterprises at the same time. All food items in WayBox are manufactured locally and specially selected to meet the daily needs of the poor households.

The idea of WayBox started during the early Movement Control Order (MCO). Various local food products were consolidated and packed into the food boxes by Linaco's Intentional CSR Initiatives (ICI) team. WayBoxes started to make its way to underprivileged families in July.






To date, 2,500 WayBox were packed and distributed to beneficiaries including families from MyKasih Foundation, Dignity For Children Foundation, HELP Community Learning Centre, House Of Hope Penang and Kechara Soup Kitchen network.
